## PRACTICAL INFORMATION

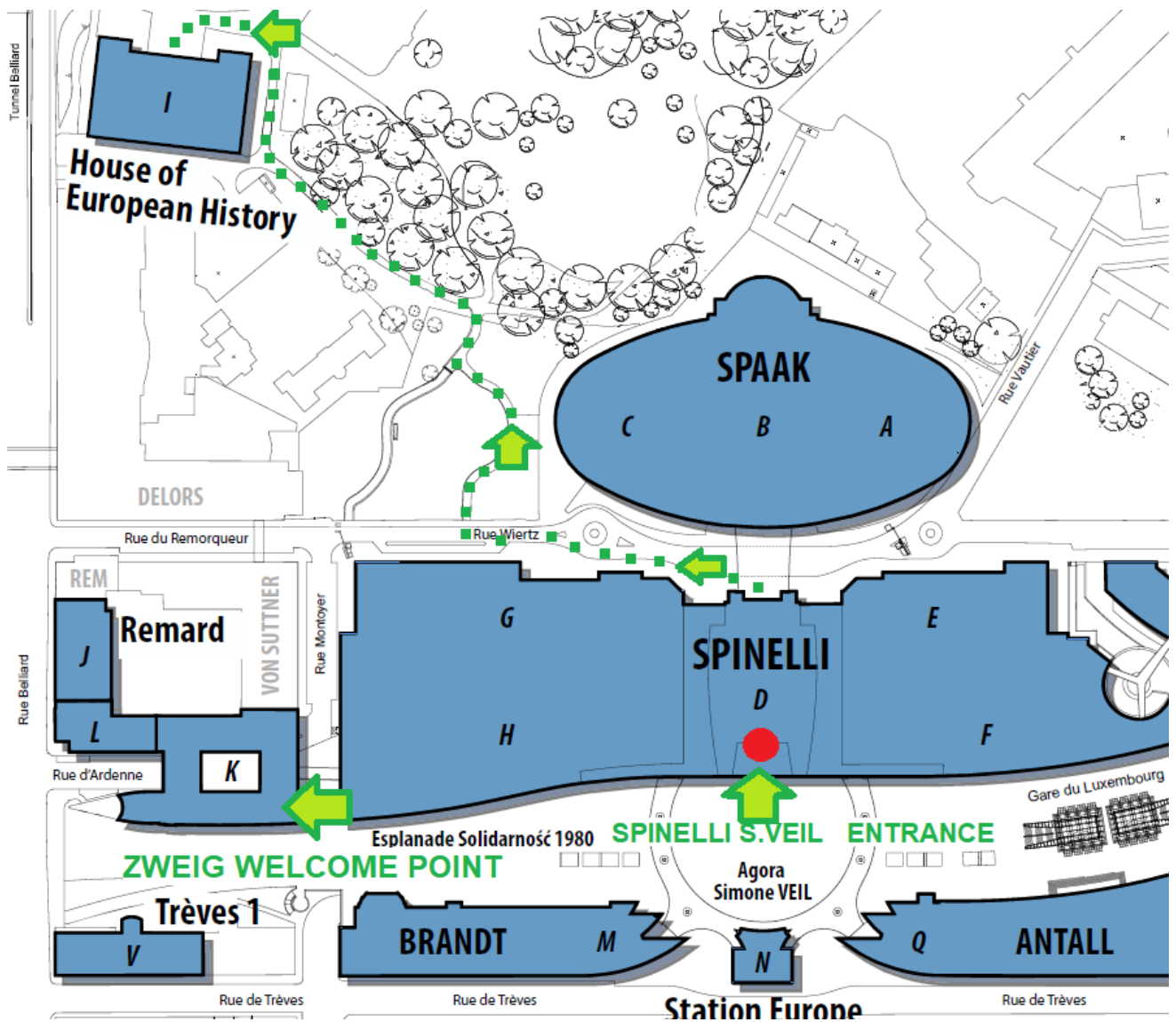
European Parliamentary Week 2020 (EPW) is co-organised by the European Parliament and the Croatian Parliament and covers:

- The **European Semester Conference**; and
- The **Interparliamentary Conference on Stability, Economic Coordination and Governance in the European Union**.

### ARRIVAL AND DISTRIBUTION OF ACCESS CARDS

Registered participants from national Parliaments can collect their access cards at the “**ZWEIG Welcome Point**” (**Esplanade Solidarność entrance**). It is on the left-hand side of the Altiero Spinelli building (SPINELLI) when viewed from Place du Luxembourg and opposite of the Parliamentarium marked on the map below

After having picked up their badges at the registration desk, participants can enter the European Parliament through the “Simone Veil” entrance of the Altiero Spinelli building (marked with a red circle below).



Registered participants can collect their access cards from the registration desk during the following hours:

**Tuesday, 18 February 2020, 11h30 - 15h00**  
**Wednesday, 19 February 2020, 8h30 - 09h00**

Alternatively, the Brussels-based representatives of the national Parliaments accredited to the European Parliament can collect the access cards for their delegations from the office of **Ms Raluca Nastase-Anysz** and **Ms Cristina Hellara** ([office MTY 70/ 07R026](#)) on **Monday 17 February from 09h30 to 12h30 and 14h30 to 16h30** and **Tuesday 18 February from 09h30 to 11h00**. After the Brussels-based representatives collect the access cards for their delegation, they are entirely responsible for their distribution to the delegation members.

Participants will receive one single access card which will be valid from 18 to 19 February 2020, and should, therefore, keep it for the whole duration of EPW.

**PLEASE NOTE THAT DUE TO THE HEIGHTENED SECURITY ALERT LEVEL AT THE EUROPEAN PARLIAMENT, ALL MEETING PARTICIPANTS:**

- must show a valid official passport or photo-ID before entering the building;
- must undergo security controls at the entrance of the premises;
- are advised to carry the invitation letter or any other document that clearly indicates their participation.

**Participants should carry their access card visibly throughout their stay in the European Parliament.**

The security department of the European Parliament will do its utmost to minimise the queuing time at the security controls for participants of European Parliamentary Week. Please note that given the number of participants attending this event, it is recommended that participants leave sufficient time to pass through security controls.
